This Certificate Of Transfer Made Mar. 30, 2021, between **FOREST GREEN PARK CEMETERY ASSOCIATION**, an incorporated Cemetery Association of the State of New Jersey, as Transferor, AND

AMVETS Department of New Jersey as Transferee

Witnesseth that the said Transferor, in consideration of

Three Hundred***** Dollars

to it paid by the Transferee, the receipt whereof is hereby acknowledged, does hereby sell and transfer unto the Transferee their heirs and assigns forever, for human interment purposes only, and for no other use or purpose whatsoever.

The right of interment in the Cemetery of the Transferor, known as the Rolling Hills Area of Forest Green Park Cemetery, situated in the Township of Marlboro, Monmouth County, New Jersey, and designated on the map of said Cemetery on file in the office of said Cemetery, number and described as being in:

SECTION (C)

Block SIX Row C Lot 1 Plot A Grave Nos. 3&4 Size of Plot 2 single graves

Description _____

To have and to use the hereinbefore described interment right to the Transferee, his, her or their heirs, successors and assigns forever, to be used for human interment purposes only, and for no other use or purpose whatsoever, and the Transferee covenants for himself, herself or themselves and for his, her or their heirs, successors and assigns that said interment right shall and will be used for no other use or purpose whatsoever.

Subject to the franchise of the Transferor its successors and assigns, and subject to the by-laws, rules and regulations of the Transferor, its successors and assigns, now in force or hereafter adopted and/or as hereafter amended, supplemented and/or revised, for the government and control of said Cemetery and/or the interment right comprising the same, and/or any part thereof, (and the same are made a part hereof in all things as if contained and repeated herein); and subject to Transferor's right to substitute another assigned location in the same or similar section of the Transferor Cemetery at any time up to an actual interment if the aforesaid assigned location is either:

- 1) In an undeveloped section or area at time of need, or
- 2) Within an area chosen as the site for the construction of a mausoleum, chapel, office, or other structure used for cemetery purposes. All of which are hereby accepted by the Transferee for his, her or their heirs, successors and assigns, and the Transferee for his, hers of their heirs, successors and assigns, does hereby covenant and agree to comply therewith.

The covenants herein contained on the part of Transferee to be observed, kept and performed are attached to and shall continue to be covenants running with the land, enforceable only by the Transferor, its successors in interest and assigns.
